RE-INVITATION FOR BID

Supply, Installation, Commissioning and testing as turn key contract for PA/SIS/AVC system in Senate Hall Parliament House, Islamabad.

1. The employer Capital Development Authority invites sealed bids in accordance with the single stage two envelopes bidding procedure for the project stated below at '2' on turn key basis from eligible firms licensed by the Pakistan Engineering Council (PEC) in Category C-3 or above. A foreign bidder is entitled to bid only in a joint venture with a Pakistani contractor in accordance with the provision of PEC by Laws. Firms / Manufacturers desirous of participating in the bid must full-fill the following qualifications:

- i. Has completed at least 03 turn key contracts, with a minimum value mentioned here in below during the last 10 years.
- ii. Has designed, supplied and installed at least one similar facility, during the last five years.
- iii. Has an average annual turnover during the last five years, equal to or more than the value mentioned here in below.

3. TERMS AND CONDITIONS

1. The tenders will be received and opened after 30 minutes by the Director (Coord) Parliament House.
2. **i)** Tenders can be purchased on cash payment mentioned above (Non-refundable) from the office of the under-signed on any working day (upto 10-12-2009 during office hours).
ii) The firms / parties who have already purchased the bidding documents need not to purchase again.
3. Earnest money in the shape of deposit at call in favour of Deputy Director (E&M), CDA, PH must be attached with the tenders at the time of submission. However, earnest money is not required to be submitted for obtaining the Tender Documents.

4. The applications for the purchase of tenders must bear name, address and signatures of the Bidder / firm, along with copy of NIC.
5. Authority letter from the firm maybe produced in favour of the person deputed by the firm to submit the application and collect the tender documents of the work.
6. The CDA reserves the right to accept or reject any tender.
7. Professional Tax Certificate is also required to be attached with the tender documents.
8. The tender will only be issued to the interested parties on the production of above mentioned documents.
9. The contract period for the Project is 180 days.

11. A Pre-Bid meeting will take place at 1100 hours on 12-12-2009 in the office of Member Engineering CDA at CDA Head office, G-7/4 Islamabad, in which only the parties / firms will participate who have purchased the tender documents by the due date.
12. The prospective bidders are advised to visit and examine the sites in consultation with concerned CDA Establishment at their own cost & arrangement to make themselves well informed of scope of the work, preferable before Pre-Bid Meeting date.
13. Technical Bid will be opened first immediately after the deadline in the presence of bidder's representatives who choose to attend. At the end of the evaluation of the Technical Bids, the Employer will invite bidders who have submitted substantially responsive Technical Bids and who have been determined as being qualified for award to attend opening of the Price Bids. The date, time and venue of opening of Price Bid will be intimated separately.
