In addition to the Chairman/ Members, Director Estate Management-II (for item Nos.1,2,3) Director One Window Operation(OWO) (for item No. 5) attended the meeting. Member Engineering was assisted by respective formation DGs./Directors. Meeting commenced with the recitation of "Holy Quran" by Mr. Muhammad Wishaq, Secretary CDA Board. Thereafter agenda items were taken up for discussion and the following decisions were made:-

# **DECISION:**

The Board noted that the in presence of pending CPLA in honourable Supreme Court of Pakistan, with no restraining order available against the order of High Court; the Order of High Court is binding upon the Authority. It was also noted that no written commitment on behalf of applicant to withdraw CPLA is available. The Board decided to defer the restoration of the plots till final disposal of the CPLA by the Supreme Court of Pakistan.

REQUEST FOR ISSUANCE OF NOC TO UTILIZE CDA LAND / FACILITIES FOR MURREE SHUTTLE SERVICE.

#### **DECISION:**

The Board observed that immediate stoppage of Diplomatic Shuttle &Transport Service (DS&TS) will create problems for the visa seekers as no alternate arrangements are presently available without compromising the security of Diplomatic Enclave. The Board also directed that Director Municipal Administration (DMA) to start the process of prequalification and calling of tenders as per Public Procurement Regulatory Authority (PPRA) Rules for this site before expiry / termination of agreement.

The Board approved the request of TDCP, Government of the Punjab, for issuance of NOC for Soft Launch of Murree Shuttle Service from the premises/site of DS&TS by utilizing their facilities, on temporary basis till expiry/ termination of the agreement/ contract. After issuance of said NOC, the necessary modalities/ formalities would be worked out by the Directorate of Municipal Administration, CDA. This NOC will have no impact on the terms and conditions of present agreement/ contract with DS&TS and will be issued after vetting by from Law Directorate of CDA.
