RECOMMENDATIONS / DECISIONS OF THE NATIONAL ASSEMBLY STANDING COMMITTEE ON CABINET SECRETARIAT – REQUEST FOR ALLOTMENT OF COLD STORAGE PLOT NO. 10, SECTOR I-11/4, ISLAMABAD.

DECISION

The Board regretted to allot cold storage plot no. 10, sector I-11/4, on the grounds that:

- a) The applicant submitted request for allotment of cold storage Plot on 30-08-1993 under Land disposal in Islamabad Regulation, 1988. The application was under process when regulations were changed. As per Islamabad Land Disposal, 1993, the Industrial plots were to be disposed off through open auction.
- b) Mere submission of application does not establish nay right of allotment.
- c) Honorable Wafaqi Mohtasib on 18-02-1998 ordered as under:"Findings having been complied with by considering the complainant case,
 if he is dissatisfied he may go to the court, no further investigation called
 for".
- d) The applicant filed a writ petition No.779/2011, titled Muhammad Ilyas VS CDA in the Islamabad High Court and the decision of the Islamabad High Court dated 14-03-2012 in this regard is as under:
 - "In the circumstances, the respondent is directed to consider the case of the petitioner in accordance with law, rules and procedure expeditiously preferably within a month. Accordingly, writ petition stands disposed of with all CMs".
 - In compliance of the above said orders of the Honorable Islamabad High Court, the case was submitted to the Authority for consideration and decision. The allotment of Cold Storage plot was not agreed by the Competent Authority being violative of prevailing Land Disposal Regulations. The decision of the authority was conveyed to the applicant.
- e) Recommendations made by the National Assembly Standing Committee on Cabinet Secretariat regarding allotment of Cold Storage Plot were considered in the CDA Board on 07-12-2012 and matter was referred to the Law and Justice Division through Cabinet Division. The advice of the Law and Justice Division has been received but cannot be made basis for allotment.

- f) CDA Board has considered this case in its meeting held on 09-12-1997, 26-12-2009, 03-08-2010, 18-10-2010, 10-11-2010, 01-02-2011 and 07-12-2012, but did not agree with allotment of this plot.
- g) The matter is under NAB's consideration/scrutiny.
- h) As per Clause-9 of Islamabad Land Disposal Regulations (IDLR), 2005, the Industrial Plots shall be sold or leased through open auction; hence the case is not covered under IDLR, 2005.
- i) The Board has further decided to put the plot of cold storage in the forthcoming auction so as the applicant may also get the opportunity to participate in the open auction.
