No application will be received after given date and time. No tender will be sold on date of opening.
2. Application for issuance of tender documents shall accompany name, address(s) and signature of contractor. Authority letter in favor of the person deputed by the contractor to submit the application and collect the tender form is required along with copy of the CNIC subject to verification from the original CNIC.
3. Earnest money in the shape of deposit at call in favor of Deputy Director Roads-II, CDA from local scheduled Bank of Pakistan must accompany with the application. Without call deposit no application for issuance of tender will be entertained. Cash / Cheque will not be accepted.
4. The firms must have satisfactory experience of similar nature projects i.e. Construction of Bridges and such completion certificate(s) must be enclosed with the application duly signed by the concerned department. No application will be received or considered without having experience of similar nature works.
5. The applicant firm will have to submit a no litigation certificate/undertaking on stamp paper clearly mentioning that there is no pending litigation with any Government department/organization.
6. If any contractor wants to participate in tender opening process through their representative, then they should issue Authority Letter on letter head pad of the firm depicting complete valid address and contact numbers along with copy of CNIC.

Tender for the work mentioned above will be received and opened, on the date and time mentioned above in the office of Director Roads (North), CDA located at Old Naval Headquarter Room No.03, Sector G-6, Melody, Islamabad, in presence of the contractors or their authorized representatives who cares to attend.
