Auction Form will be issued after necessary scrutiny on **27-9-2021 in office timing**. Applications for purchase of auction forms should be submitted on their firm's letter heads including name, address, C.N.I.C, professional tax certificate, Current year tax return i.e up to 30-6-2020 of Income tax.(Original documents will be checked at the time of sale of tender documents.). Tender documents will be issued on 27-9-2021.
2. Bids shall be received & opened by the Director, Maintenance, CDA in his office located at Old Naval Complex, Melody, Islamabad in the presence of the contractors who are to attend.
3. Interested bidders in the auction shall have to furnish a deposit at call for **Rs.1, 000, 000/-** (Rupees One Million only) in favour of DDO Shah Faisal Masjid Project, CDA along with sealed bids. Bids received without call deposit will not be entertained and will be rejected. Cash / Cheque will not be accepted.
4. Bidder shall have to furnish a separate deposit at call for two months quoted rate amount in favour of DDO Shah Faisal Masjid Project, CDA along with sealed bids. Bids received without call deposit will not be entertained and will be rejected. Cash / Cheque will not be accepted. (In case of non-commencement of work given dated amount shall be forfeited).
5. C.D.A may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall, upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.
6. The C.D.A shall announce the results of bid evaluation in the form of a report giving justification for acceptance or rejection of bids at least ten days prior to the award of the subject contract.
7. Sealed bids will be received upto 11:30 AM and will be opened at 12:00 Noon.
8. Auction notice can be seen at CDA and PPRA Websites.
9. The contractor or their representatives must ensure to remain present at the time of opening of auction & sign the tender register.
10. Tender notice has been prepared as per PPRA rules.
11. That deposit at Call/Earnest Money should be generated only from firm's accounts.
12. The general/Special Power of attorney may be attested through respective court.
13. That the attorney holder may not be the employee of any Government semi Government institute.
14. That no such application be entertained without valid PEC license.
15. That only legitimate attorney holder may be allowed to get tender documents.
16. That the relative of tendering authority may not be entertained for participation in the tenders.
