I am directed to inform that during site visit dated 12-04-2021, it has been observed that *illegal and un-authorized housing scheme* namely *Rawat Housing Scheme* is being developed at a rapid pace located at G.T. Road, Rawat, Zone-V, Islamabad. The work/structure/building is being constructed/erected and land is being used in contravention of the provisions of CDA Ordinance 1960, ICT (Zoning) Regulation, 1992 (amended in 2010) and Islamabad Capital Territory Building Control Regulations, 2020.

- 2. You are therefore directed to immediately stop making any illegal/un-authorized development in this illegal and un-authorized housing scheme, otherwise strict legal action would be initiated, under prevailing rules/regulations.
