No tender will be sold on the date of opening of tender.

3. Tender will be issued to those firms who have valid PEC registration certificate having appropriate clause in PEC and valid Electrical License for Islamabad region issued by Electrical Inspector Islamabad. Tender will be issued only those firms who have completed their work within due time period and satisfactory.

4. Tender will be received upto 11:30am and will open at 12:00 Noon as mentioned above in the presence of representatives of contractor who may care to attend the office of Dy. Director Mechanical-II, CDA, Room No.1 "Q" Block Pak Sectt Buildings Islamabad.

5. Contractors shall produce valid/renewed PEC registration certificate and Earnest Money along with tender. Earnest Money must be in the shape of call deposit that deposit at call / Earnest Money should be generated only from Firms accounts, in favor of Deputy Director Mechanical Division II CDA, no cash/Cheque equal to amount of Earnest Money will be accepted.

6. Bidder should visit the site and study carefully the bidding documents to assess quantum and scope of work before filling and submitting tender.

7. In case of representative the general / Special Power of attorney may be attested through respective court. That the attorney holder may not be the employee of any Government / Sami Government Institute. If the contractor or his authorize representative does not sign the tender opening register, their call deposit will be liable for forthwith and their tender will also be cancelled.

8. CDA may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The CDA shall upon request communicate the grounds for its rejection but shall not be bound to justify those grounds.

9. The bid security of all bidders would be deposited in the CDA Bank account and same may be returnedp after the acceptance of the contract with the successful bidder.

10. The eligibility criteria of the firms with the relevant experience i.e. at least three number of work in last two financial years may be observed / fulfilled before issuance of tender documents.
