**Conditions.**

Director Environment, CDA**, situated in F-9 Park, Islamabad on any working day before the date of opening of tender on cash payment mentioned as above (non-refundable / Non-transferable). No tender will be issued / sold on the date of opening of tender.
- Tenders will be received and opened in the office of Director Environment (West) / Park (West) in F-9 Park, Islamabad in the presence of Tender Committee, contractors or their authorized representatives at fixed date and time given above.
- Earnest money in shape of deposit at call in favor of **DDO's** mentioned above must be accompanied with the tender. No tender will be issued without call deposit. Earnest money / Call deposit shall be generated only from firm's accounts.
- The competent authority reserves the right to reject any or all tenders as per PPRA rule.
- No application will be entertained for issuing of tender documents on the last date of issuing of tender( 01 day before opening) after **12:00 PM**.
- Tender will be issued only to those firms bearing renewal copy of license from PEC in relevant category.
- In case, the total bid amount is less than 10% below the NIT amount, the bidder shall submit additional call deposit as performance security equal to the difference between NIT amount and total quoted amount less 10% of NIT amount. This additional performance guarantee (call deposit) shall be submitted along with bid enclosed envelope. Bids having rates below 10% of NIT without additional call deposit will be rejected. The performance security of the successful bidder shall be released after completion of project.
- Application for issuing of tender documents submitted on printed pad bearing name / address / signature of contractor along-with power of attorney, partnership deed, and proprietorship deed, valid professional Tax Certificate, renewal PEC license, attested copy of NTN certificate and attested copy of CNIC.
- The bid security of all bidders would be deposited in the CDA Bank account and same may be returned after the acceptance of the contract with the successful bidder.
- The eligibility criteria of the firms with the relevant experience i.e. at least three numbers of work in last two financial years may be observed / full filled before issuance of tender documents.
