CONDITIONS:



- a. Tender Documents can be purchased on payment of Rs.3,000/- (Rupees three thousand only) for each tender (Non-refundable) in shape of cash from the office of **Dy. Director W&S R/A Zone, Room # 136 Capital Development Authority Old Naval Headquarter G-6 Markaz, Melody Market**, upto **22.09.2021** before closing hours. No application for tenders will be received after schedule date and time.
- b. Tenders will be issued to those firms who provide copies of valid PEC License for the current financial year having appropriate Category / Codes C-6 or above with project code CE-09 and NTN and GST registration certificate along with written request on original letter pad of firm / contractor. In case of representative, copy of CNIC along with authority letter / original power of attorney may also be attached with application. **PEC Certificate & Professional Tax Certificate 2021-22 in original will also be seen before issuance of Tender Documents.**
- c. Bid Security / Earnest Money shall also be accompanied with the request in the shape of Deposit at Call (CDR) clearly indicating the Name of Firm issued by local scheduled bank in favor of Deputy Director W&S RA Zone, CDA and should be generated only from Firm's account. Cash / Cheque open CDR without indicating name of firm will not be accepted and no application without Bid Security / Earnest Money will be accepted for issuance of tender.
- d. The tender will be issued only to those firms who provide at least 03 work orders for last 02 financial years in the relevant field.
- e. The tender will be issued only to those firms who provide an undertaking on Stamp Paper worth not less than Rs.50/- that the firm / contractor are neither involved in any litigation nor black listed by any government, semi government or autonomous body in Pakistan and also undertakes that if any information or document provided by firm for issuance of tender document is found incorrect or fictitious the firm is liable for legal action under the law. Without the undertaking tender will not be issued to firm.
- f. If the contractor wants to participate in the tendering through representative, the contractor will provide general / special power of attorney duly attested by respective court and only to legitimate attorney holder would be allowed to get tender documents.
- g. Relative of tendering authority may not be entertained for participation in the tenders.
- h. Tenders will be opened by Director W&S (Dev), CDA in the office of Director W&S (Dev), CDA Room # 131 Old Naval Headquarter G-6 Markaz Melody Market, Islamabad on schedule date & time.
- i. CDA may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The CDA shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals but is not required to justify those grounds.
- j. In case of any Gazetted / Occasional holiday(s), the tenders will be opened on the next working day.
- k. The Bid Security / Earnest Money and Performance Security of unsuccessful bidders will be retained / deposited in CDA bank account and released in the favor of firm's account only after acceptance of bid.
