TERMS & CONDITIONS:

1. Tender document can be obtained from the office of Deputy Director (Forest) CDA, F-9, Park Islamabad on any working day before the date of opening of tender on cash payment of Rs.5000/- (nonrefundable). No tender will be issued/sold on the date of opening.
2. Tender will be received and opened in the office of Director Environment Protection Cell, CDA in F-9 Park, Islamabad in presence of contractors and representatives at the fixed date and time given above.
3. Earnest money in the shape of deposit at call in favor of the undersigned must be accompanied with the tender. No tenders will be issued without a call deposit. The competent authority reserves the right to reject any or all tenders. The competent authority shall upon request communicate to any contractor who participated in tendering, the grounds for its rejection, but is not required to justified those grounds.
4. Tenders will be issued to those parties who are working in the field of plantation and having at least 5 years experience.
5. In case of total bid amount is less than 10% below the NIT amount, the bidder shall submit additional call deposit as performance security equal to the difference between NIT amount and total quoted amount less than 10% of NIT amount. That is required performance security=NIT amount – total bid amount – 10% of NIT amount. This call deposit shall be in addition to the earnest money for the work and shall be deposited at the time of submission of bids. The bid not carrying this performance security shall be rejected. The performance security of the successful bidder shall be released after completion of the project.
6. The bidders are required to provide the following additional documents while submitting the tender; otherwise, it will be liable for rejection. (Power of attorney, Partnership deed, Programme of work non-judicial stamp paper worth 10/- Professional Tax Certificate, Registration/Renewal of the Firm with the authority.
7. Application for the issuance of tender on printed Pad bearing name/address/signature of the contractor and attested copy of C.N.I.C experience (work order) regarding plantation works in original must be submitted for issuance of tender.
8. Tender rates on percentage basis shall be written in figure, without any cutting / overwriting and same shall also be shown in words without cutting / overwriting.
9. The Authority may reject all the bids at any time prior to the acceptance as per PPRA rules. However, the authority shall upon request communicate to any contractor who submitted a bid, on the ground of its rejection of all bids, but not bound to justify those grounds.
