  - ii. Application for issuance of tender documents shall accompany name, address(s), signature of contractor, valid enlistment/renewal of Firm with PEC along with proof of relevant experience regarding similar nature of works. (at least one work orders)
  - iii. Authority letter in favor of person deputed by the contractor to submit the application and collect the tender form is required from contractors along with copy of the CNIC subject to verification from the original CNIC.
  - iv. Earnest Money in the shape of deposit at call in favor of Deputy Director (KDP), CDA from local scheduled Bank of Islamabad must accompany with the application. Without call deposit no application for issuance of tender will be entertained. Cash/ Cheque will not be accepted.
  - v. If any contractor wants to participate in tender opening process through their representative, then they should issue authority letter on letter head pad of the firm depicting complete valid address & contact numbers along with attested copy of CNIC.
  - vi. Tenders for the work mentioned above Sr. No. 01 to 04 will be received and opened on the date & time mentioned above in the office of Director Bulk Water Management, CDA located at Bazar No:8, Office No:8 Sector G/6-4 Islamabad in presence of the contractors or their authorized representative who cares to attend.
  - vii. In case the total bid amount is less than 10% below the NIT amount, the bidder shall submit call deposit as performance security equal to the difference between NIT amount and total quoted amount less 10% of NIT amount. That is, required performance security = NIT amount – total bid amount – 10% of NIT amount. This call deposit shall be in addition to the earnest money for the work and shall be deposited at the time of submission of bids. Bids not carrying the performance security shall be rejected. The performance security of the successful bidder shall be released after completion of the project.
  - viii. The contractors will submit the documents as per bidding/tender documents along with their tender, without which tender will be liable for rejection.
  - ix. CDA may reject all bids or proposals at any time prior to acceptance of a bid or proposal. The CDA shall upon request communicate, to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.
