2. That the contract must be observed the following conditions before purchase of the tender documents as approved by the competent Authority.

- i) That deposit at call / earnest money should be generated from firms account.
 - ii). The general / Special Power of attorney may be attested through respective Court.
 - iii) That the attorney holder may not be the employee of Government / Semi Government institute.
 - iv) That only legitimate attorney holder may be allowed to get tender documents.
 - v) Contractor should provide documentary evidence of similar nature of work at least three number of completion certificates from the government / semi government organization in last two financial years before issuance of tender documents will be observed .
 - vi). That the bid security of all bidders would be deposited in the CDA bank account and same shall be returned after the acceptance of the contract with the successful bidder.
3. Tender Forms/documents can be purchased on cash payment of Rs.5000/- (Non-refundable) from the Dy. Director Sports, Culture & tourism, on up to 24-06-2022 before closing hour. No application for tenders will be received after schedule date and time.
4. Tender will be issued to those firms who having valid PEC registration certificate with appropriate category Codes.
5. the contractor will be responsible to keep its to on the approved list of license holder govt of Pakistan in relevant field.
6. Tender will be received up-to 11.30 AM and opened at 12.00 P.M in the office of the Dy. Director Sports, Culture & tourism, MCI, F-6 Club House Super Market Islamabad in the presence of representatives of contractors, given schedule above.
7. Contractors shall produce, valid / renewed PEC Registration Certificate, and Earnest Money in shape of Call deposit (CDR) /Bank Draft in favor of DDO Directorate of Sports Culture, MCI for issuance of tender documents.
8. In case the total bid amount is less than 10% below the NIT Amount, the bidder shall submit call deposit at performance security equal to the difference between NIT amount and total quoted amount less 10% of NIT amount. That is required performance security NIT amount total bid amount 10% of NIT amount. This call deposit shall be in addition to the earnest money for the work and shall be deposited at the time of submission of bids. Bids not carrying the performance security shall be rejected. The performance security of the successful bidder shall be released after completion of the work.
9. Bidder should visit the site and study carefully bidding documents to assess quantum and scope of work before filling and submitting tender.
10. If the contractor or his authorized representative does not sign the tender opening register, their call deposit will be liable for forfeiture and their tender shall also be cancelled.
11. MCI may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The MCI shall upon request communicate the grounds for its rejection but shall not be bound to justify those grounds.
12. In case of any Gazetted / Occasional Holiday (s), the tenders will be opened on the next working days. The following original and one photocopy attested valid documents must be provided by the firm along with application for purchasing of tender documents. Otherwise tender will be not being issue.
