1. Tenders can be purchased on cash payment of Rs. 3000 for above mention work(non-refundable) from the office of Deputy Director (CSD), located at Room No. 148 CDA Mayor Secretariat sector G-6 Markaz , Islamabad

The application for issuance of tender documents shell be on original letter head of company / firms showing name, address(s), signature of the contractor, along with Earnest money in shape of Call Deposit, valid enlistment/renewal of the firm with PEC, attested copy of CNIC, professional tax certificate, active income tax and GST certificate.
3. The owner of the firm should sbmit the application and collects the tender documents by himself. In case of representative, copy of CNIC along with general/special power of attorney attested through respective court must be attached with the application. The attorney holder must be legitimate and should not be the employee of any Government/semi Government institute.
4. Earnest money, in shape of Call Deposit in favor of D.D.O (City Sewerage Division), CDA from Local Banks, indicating name of firm must be shown on CDR being accompanied with the application without which no application shell be entertained. Cash/Cheque will not be accepted.
5. Tenders will be received by Deputy Director (CSD) up to 12:00 AM in his office in Room No.148, Mayor Sectt. G-6, Islamabad, against each work which will be opened by the Director Sanitation, CDA as per schedule date and time.
6. The contractors who are interested to participate in tenders are required to submit experience certificates of similar nature of work executed during the last two years along-with application.
7. The relative of a tendering authority should not be entertained for participation in the tenders.
8. The bid security of all bidders should be deposited in CDA's bank account and same be returned after the acceptance or rejection of successful bid.
9. PEC certificate 2022 & Professional Tax certificate, GST (Active) FBR income Tax clearance certificate in original will be seen before issue of tender.
