2. Machinery as above ought to be owned / Bank Leased by the bidders.
3. The bid shall comprise a single stage two envelopes (containing two separate envelopes). Each envelope shall contain separately the Financial and Technical proposal. The envelopes shall be marked as **“TECHNICAL PROPOSAL”** and **“FINANCIAL PROPOSAL”** in bold and legible letters to avoid confusion [PPRA- Rule 36(b)]. Initially, only the envelope marked **“TECHNICAL PROPOSAL”** shall be opened and the envelope marked as **“FINANCIAL PROPOSAL”** shall be retained in the custody of the procuring agency without being opened. Second envelope containing Financial Bids will be opened later, the date of which will be communicated to the successful bidders of Technical Bids. Financial Bids of non-qualified / non-responsive technical bidders will be returned unopened.
4. The Earnest Money in shape of Pay Order or Bank Draft in favor of Deputy Director Sanitation / DDO Sanitation shall be attached with the **“TECHNICAL PROPOSAL”**. In case of failure, Bid Documents will not be considered.
