1. Tender forms can be purchased on cash payment (non-refundable) as mentioned above from the office of Deputy Director (Simly Dam Division), CDA located at Shop No.5, Bazar No.8, G-6/4, Islamabad during working hours. No tender will be sold on the date of opening of tender.
2. The tender only those contractors/firms who have experience in relevant field more than three years with Govt. and Sami Government Departments and registered as Security Providers with the Ministry of Interior Govt. of Pakistan can participate in the bid. Renewal of license for the current fiscal year as private security company/firm by the Chief Commissioner, Islamabad Capital Territory (I.C.T) Govt. of Pakistan is also required.
3. Successful bidders will have to provide all security clearance documents etc. within 03 days of bid.
4. Application for issuance of tender documents shall accompany name, address(s), signature of contractor, valid enlistment/renewal of firm with Ministry of Interior Govt. of Pakistan.
5. Authority letter in favour of person deputed by the Contractor to submit the application and collect the tender form is required along with copy of the CNIC subject to verification from the original CNIC.
6. Earnest money in the shape of deposit at call in favour of Deputy Director (Simly Dam Division), CDA from local scheduled Bank of Islamabad must accompany with the application. Without call deposit no application for issuance of tender will be entertained. Cash/cheque will not be accepted.
7. If any contractor wants to participate in tender opening process through their representative, then they should issue authority letter on letter pad of the firm depicting complete valid address & contact numbers along with attested copy of CNIC.
8. Tenders for the work will be received and opened, on the date and time mentioned above, by the Director (Bulk Water Management), CDA in his office located at Shop No.8, Bazar No.8, G-6/4, Islamabad in presence of firms/Contractors or their authorized representatives who cares to attend.
9. The contractors will submit the documents as per item No.16 of instructions of tender documents along with their tender, without which tender will be liable for rejection.
10. In case the total bid amount is less than 10% below the NIT amount, the bidder shall submit call deposit as performance security equal to the difference between NIT amount and total quoted amount less 10% of NIT amount. That is, required performance security=NIT amount – total bid amount – 10% of NIT amount. This call deposit shall be in addition to the earnest money for the work and shall be deposited at the time of submission of bids. Bids not carrying the performance security shall be rejected. The performance security of the successful bidder shall be released after completion of the project.
11. CDA may reject all bids or proposals at any time prior to acceptance of a bid or proposal. The CDA shall upon request communicate, to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.
