Conditions.

1. Tender documents can be obtained from the office of Deputy Director Park Division, Environment Directorate (East) CDA, situated in F-9 Park opposite to F-8 Exchange Islamabad on any working day before the date of opening of tender on cash payment of Rs.5000/- (non-refundable / Non-transferable) of each tender. No tender will be issued / sold on the date of opening of tender.
2. Tenders will be received and opened in the office of Director Environment (East) in F-9 Park, Islamabad in the presence of Tender Committee, contractors or their authorized representatives at fixed date and time given above.
3. Earnest money in shape of deposit at call in favor of **DDO (East)** must be accompanied with the tender. No tender will be issued without call deposit.
4. The competent authority reserves the right to reject any or all tenders as per PPRA Rule.
5. No application will be entertained for issuing of tender documents on the last date of issuing of tender i.e 23-09-2022 after **12:30 PM**.
6. Application for issuing of tender documents submitted on printed pad bearing name / address / signature of contractor along-with power of attorney, partnership deed, proprietorship deed, valid professional Tax Certificate, renewal PEC license, attested copy of NTN certificate and attested copy of CNIC.
7. That deposit at Call / Earnest Money should be generated only from firm's accounts.
8. The General / Special Power of Attorney may be attested through respective court.
9. That the attorney holder may not be the employee of any Government / Semi Government institute.
10. That no such application be entertained without valid PEC license.

11. That only legitimate attorney holder may be allowed to get tender documents.
 12. That the relative of tendering authority may not be entertained for participation in the tenders.
 13. The Bid Security of all bidders would be deposited in the CDA Bank account and same may be returned after the acceptance of the contract with the successful bidder.
 14. The eligibility criteria of the firms with the relevant experience i.e at least three number of work in last two financial years may be observed / fulfilled before issuance of tender documents.
 15. In case of total bid amount is less than 10% below the NIT amount, the bidder shall submit additional call deposit as performance security equal to the difference between NIT amount and total quoted amount less 10% of NIT amount. This additional performance guarantee (call deposit) shall be submitted along with bid. Bids having rates below 10% of NIT without additional call deposit will be rejected. The performance security of the successful bidder shall be released after completion of project.
