- ii. The bids comprising (Technical & Final Proposals) in sealed envelopes separately should be dropped on the presented date & time.
- iii. Sealed technical bid must be duly accompanied with CDR of the requisite amount as mentioned above form firm/company's own account clearly mentioning the name of firm / company duly issued by any schedule bank in Pakistan in favor of DD (Landscape) Division Environment Wing, CDA.
- iv. Tender application should accompany with earnest money in shape of deposit at call in favor of Dy. Director Landscape Division, CDA issued from any scheduled local bank against firm's account. Name of firm should be clearly mentioned on instrument (Deposit at call). Tender documents shall not be issued without earnest money.
- v. In case of total bid amount is less than 10 % below the NIT amount, the bidder shall submit additional call deposit as performance security equal to the difference between NIT amount and total quoted amount less 10 % of NIT amount. The additional performance guarantee (Call Deposit) shall be submitted along with bid. Bids having rates below 10 % of NIT without additional call deposit will be rejected. The performance security of the successful bidder shall be released after completion of project.

Director Landscape Division, Environment Wing CDA located at Mehran Gate No.01, Fatima Jinnah Park, Directorate of Parks, CDA, Islamabad on cash payment of **Rs.10,000 /- (Rupees Ten Thousand) Per Each Set** -(Non-Refundable) during working hours on any working day before date of opening against written request which should be on letter head pad having Name, Address, Telephone (Land line) Numbers and signature of the contractor along with attested copies of NTN Certificate, valid Professional Tax Certificate, Sole proprietorship/partnership deed, etc, Moreover General/Special Power of attorney may be attested through respective court, The attorney holder may not be the employee of any Government, semi Government institute/That Only legitimate attorney holder may be allowed to get tender documents. No tender will be sold on the date of opening of the tender. Tenders will be sold upto 12:00 Noon on 25-01-2023 .
- vii. The bid security of all bidders would be deposited in the CDA Bank account and same may be returned after the acceptance of the contract with the successful bidder.
