4. Tenders for the project will be received and opened by the competent authority on date and time mentioned above in presence of Bidders or their authorized representative who may wish to attend.
5. The Firm/Company must be registered with SECP or as Sole Proprietorship. In case of Partnership mandatory registration with Registrar of Firms or with SECP in case of Pvt. Ltd. Moreover, the Firm/Company shall have valid registration with FBR.
6. Bidder (All partners in case of Joint Venture) must be registered company for Bus Operations at-least Five (05) years in the country of origin.
7. In case a foreign company, not registered in Pakistan, wants to participate in bidding process, it must form a Joint Venture with one or more local companies.
8. CDA may reject all bids or proposals at any time prior to acceptance of bid or proposal as per PPRA rule 33.
9. The Procurement method shall be Single Stage Two Envelope Bidding Process, PPRA 2004 36(b).
