- Tenders forms/ documents can be purchased on cash payment(non-refundable) for the works mentioned at Sr. # 01 to 11 from the office of Deputy Director (CSD), CDA located at Room No. 147, first Floor, CDA Mayor Secretariat sector G-6 Melody , Islamabad during working hours. Last date for submission of application for purchase of tender form documents is 07-04-2023 till 12:00 Noon and tender form documents will be sold on 10-04-2023 till 12:00 Noon.
- Application on original letter Pad for issuance of tender documents shall accompany the name, address(s), signature of the contractor, and valid enlistment/renewal of the Firm with PEC, attested copy of CNIC, Professional Tax certificate, active NTN/GST certificates and at least three number of work order of similar nature during last two financial years 2020-21 & 2021-22
- The owner of the firm should submit the application and collects the tender documents by himself. In case of representative, copy of CNIC along with general/special power of attorney attested through respective court must be attached with the application. The attorney holder must be legitimate and should not be the employee of any Government/semi Government institute.
- Earnest money, in shape of Call Deposit in favor of D.D.O (City Sewerage Division), CDA from Local Banks, indicating name of firm must be shown on CDR being accompanied with the application without which no application shall be entertained. Cash/Cheque will not be accepted.
- Tender for the work mentioned above will be received and opened by Director Sanitation, CDA, in his room No. 05, Ground Floor Sector G-6/1-4, Islamabad in the presence of contractors or their authorized representatives who care to attend
- The contractors who are interested to participate in above mentioned tenders, they will have to submit three number of completion certificates of completed works of similar nature during the last two financial years i.e 2020-21 and 2021-22 while submitting applications, otherwise tender will not be issued
- The relative of a tendering authority should not be entertained for participation in the tenders.
- The bid security of all bidders should be deposited in CDA's bank account and same be returned after the acceptance or rejection of successful bid.
- In case the total bid amount is less than 10% below the NIT amount, the bidder shall submit call deposit as performance security equal to the difference between NIT Amount and total quoted amount less 10% of NIT amount. That is required performance security=NIT amount total bid amount 10% of NIT amount. This call deposit shall be in addition to the earnest money for the work and shall be deposited at the time of submission of bids. Bids not carrying the performance security shall be rejected. The performance security of the successful bidder shall be released after completion of the project
- PEC certificate 2022-23 & Professional Tax certificate, GST (Active) FBR income Tax clearance certificate in original will be seen before issue of tender.
- Firm/contractors will provide an under taking on stamp paper worth Rs. 50/- for the work that firm/contractors in not involved in any litigation with CDA, not involved in any financial related inquiry being probed by any invested agency and not black listed by any Government, semi Government or autonomous body in Pakistan. In case of false or incorrect statement, tender will be rejected and legal action will also be taken against the defaulter.
- CDA reserved the rights to accept or reject any or all bids or proposals at any time without prior notice.
