No. 01 to 09 and at S.No.10 can be obtained Rs.2000/- each, (Non-refundable) from the office of Deputy Director Mechanical Division II CDA, **Room No.1 "Q" Block Pak Sectt Building Islamabad** on working days during office timings. **No tender will be sold on the date of opening of tender.**

3. Tender will be issued to those firms who have valid PEC registration certificate having appropriate clause in PEC relevant code and Electrical license.

4. Tender will be received upto 11:30 Am and will be opened at 12:00 Noon on above mentioned date in the presence of contractors /representatives who may care to attend the office of Dy. Director Mechanical Division-II, CDA, **Room No.01 "Q" Block Pak Sectt Building Islamabad.**

5. Contractors should provide valid/renewed PEC registration certificate and Earnest Money along with tender. Earnest Money must be in favor of Deputy Director Mechanical Division II CDA in the shape of call deposit / which should be generated from Firms own accounts only. **No cash / Cheque equal to amount of Earnest Money will be accepted.**

6. Bidder should visit the site and study carefully the bidding documents to assess quantum and scope of work before filling and submitting tender.

7. In case of representative the general / Special Power of attorney may be attested through respective court. That the attorney holder may not be the employee of any Government / Sami Government Institute. If the contractor or his authorize representative does not sign the tender opening register, their call deposit will be liable for forthwith and their tender will also be cancelled.

8. CDA may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The CDA shall upon request communicate the grounds for its rejection but shall not be bound to justify those grounds.

9. The bid security of all bidders will remain in the custody of Accounts Section and after acceptance of contract / bid will be returned to remaining unsuccessful contractors.

10. The eligibility criteria of the firms with the relevant experience i.e. at least **3 number of work orders** in last two financial years may be observed / fulfilled before issuance of tender documents.

11. In case of any Gazetted/Occasional Holiday(s), the tenders will be opened on the next working day.

12. The following additional valid documents must be submitted by the firm while submitting the tender, otherwise will be rejected:-

- i. Power of attorney if required.
- ii. Partnership deed if any.
- iii. Program of work.
- iv. Non-relationship certificate.
