- The bid security of all bidders would be deposited in the CDA Bank Account and same may be returned after the acceptance of the Contract with the successful bidder.
- The firm shall provide all relevant attested documents according to laid down in invitation for bids in bidding documents otherwise bids will be considered as a non responsive bid.
- Authority letter (on original letter head of firm) in favor of the person deputed by the contractor to submit the application and collect the tender from along with CNIC {original} is to be provided.
- Certificate is required on Judicial Stamp Paper worth of Rs.50/- (Original) that their firm are not involved in any litigations & not black listed in any Govt Organization.
