CONDITIONS.

- i. Application for the tender document for above mention work shall be received upto 21-9-2023 till 12.00 (Noon).
- ii. That deposit at call/Earnest money should be generated only from firms account and in the name of firm.
- iii. Power of attorney dully registered in respective court for the each work/works.
- iv. That the attorney holder may not be the employee of any Government/Semi Government institute.
- v. That only legitimate attorney holder may be allowed to get tender documents.
- vi. The bid security of all bidders would be deposited in the CDA Bank account and same may be returned after the acceptance of the contract with the successful bidders.
- vii. Tender documents can be obtained on receipt of pay order (Nonrefundable) in the Name of Dy: Director Maint-III (SB) of the prescribed fee for the work as mentioned above from the office of the undersigned.
- viii. No tender documents will be sold on the day of opening of the tender.
- ix. The tender document shall only be issued to the owner of firms or legitimate attorney holder, if the contractor or his legitimate attorney holder does not sign the tender opening register their call deposit will be liable forfeited.
- x. Satisfactory performance certificate must be submitted by the bidder.
- xi. Tender should be received and open by the Director Maintenance, CDA as per schedule given above. CDA may reject all bid or proposal at any time prior to the acceptance of a bidder or proposal as per PPRA rule.
