Tenders forms/ documents can be purchased on cash payment(non-refundable) for the work mentioned above from the office of Deputy Director (CSD), CDA located at Room No. 147, first Floor, CDA Mayor Secretariat sector G-6 Melody, Islamabad. The last date for submission of application for purchase of tender form documents is 20-09-2023 till 12:00 Noon and tender form will be issued only the eligible contractors after scrutiny of the documents on 25-09-2023 up to 01:00 PM. No tender will be sold/issued on the date of opening of tenders.
2. Application on original letter pad for issuance of tenders documents shall accompany the name, address(s), telephone (land line) numbers and signature of the contractor along with separate attested photocopies of CNIC, NTN certificate, sole proprietorship/partnership deed, valid PEC license for the year 2023-24 in specialized code CE\_09 and at least three number of work orders of similar nature during last two financial year 2021-22 and 2022-23.
3. The owner of the firm should submit the application and collects the tender documents by himself. In case of representative, copy of CNIC along with general/special power of attorney attested through respective court must be attached with the application. The attorney holder must be legitimate and should not be the employee of any Government/semi Government institute or autonomous body.
4. Earnest money, in shape of Call Deposit in favor of D.D.O (City Sewerage Division), CDA from scheduled Banks of Islamabad indicating name of firm must be shown on CDR being accompanied with the application without which no application will be entertained. Cash/Cheque will not be accepted.
5. Tender for the work mentioned above will be received and opened by Director Sanitation, CDA, in his room No. 05, Ground Floor Sector G-6/1-4, Islamabad in the presence of contractors or their authorized representatives who care to attend
6. The relative of a tendering authority should not be entertained for participation in the tenders.
7. The bid security of all bidders should be deposited in CDA's bank account and same be returned after the acceptance or rejection of successful bid.
8. In case the total bid amount is less than 10% below the NIT amount, the bidder shall submit call deposit as performance security equal to the difference between NIT Amount and total quoted amount less 10% of NIT amount. That is required performance security=NIT amount total bid amount 10% of NIT amount. This call deposit shall be in addition to the earnest money for the work and shall be deposited at the time of submission of bids. Bids not carrying the performance security shall be rejected. The performance security of the successful bidder shall be released after completion of the project
9. PEC certificate 2023-24 & Professional Tax certificate 2023-24, GST (Active) FBR income Tax clearance certificate in original will be seen before issuance of tender.
10. Firm/contractors will provide an under taking on stamp paper worth Rs. 50/- for the work that firm/contractors is not involved in any litigation with CDA, not involved in any financial related inquiry being probed by any investigated agency and not black listed by any Government, semi Government or autonomous body in Pakistan and no member o his firm who has a financial interest in its profit and loss is a gazetted officer of CDA. In case of false or incorrect statement, tender will be rejected and legal action will also be taken against the defaulter.
11. CDA reserved the rights to accept or reject any or all bids or proposals at any time without prior notice.
