- The prospective bidders shall upload scanned copy of Certificate is required on Original Judicial Stamp Paper for each tender worth of Rs. 100/- for non-relationship in CDA.
- The prospective bidders are required to submit their Bids online through E-PADS at <http://eprocure.gov.pk> and as per instructions contained in Bidding Documents on or before **20-10-2025 at 11:30 hrs.** Manual Bids will not be entertained.
- The electronic Bids will be opened by using EPADS publicly on the **same day at 1200 hrs**, in the presence of the procurement committee & Bidders' authorized Representatives who choose to attend the opening session to be held at the office of Director Roads(South), CDA Room No 59, Old Naval Head Quarter Building G-6, Melody, Islamabad.
- In case the total bid amount is less than **10% below** the NIT amount, the bidder shall submit call deposit as performance security equal to the difference between NIT amount and total quoted amount **less 10%** of NIT amount. This call deposit shall be in addition to the earnest money for the work and shall be deposited at the time of submission of bids. Bids not carrying the performance security shall be rejected. The performance security of the successful bidder shall be released after completion of the project.
