- The prospective bidders are required to submit their Bids online through E-PADS at http://eprocure.gov.pk and as per instructions contained in Bidding Documents on or before 22-12-2025 at 1500 hrs. Manual Bids will not be entertained.
- The Electronic Bids will be opened by using EPADS publicly on the same day at 1530 hrs. in the presence of the Procurement Committee & Bidders' authorized Representatives who choose to attend the opening session to be held at the office of Director (P&CA-I), Room No 29, Block III, P&C Wing, CDA Secretariat, Sector G-7/4, Islamabad.
