- 4. Meeting commenced with the recitation of "Holy Quran" by Chaudhary Muhammad Ali Randhawa, Chairman, CDA and Chief Commissioner ICT.

Thereafter agenda items were taken up for discussion and following decisions were made:-

1.1 GENERAL DISCUSSIONS / DIRECTION & CONFIRMATION OF MINUTES OF PREVIOUS BOARD MEETING.

During the discussion in the meeting, the Board directed the following: -

- The Estate Wing was instructed to determine the expiration dates of leases of land for Houses allotted to the provinces. For those requiring extensions, a one-time lease extension will be granted, allowing the CDA to impose the applicable lease extension charges as determined.
- The Planning Wing was instructed to assess and identify any excess land allocated to Sindh House. If any surplus land is identified, it will be reallocated to Capital House.
- Engineering Wing was directed to initiate a summary seeking approval of the Federal Cabinet for disengagement of NAPHDA from Low-Cost Housing Project at Farash Town.
