- Capital Development Authority invites sealed proposals from eligible firms that appear on the list of approved valuers of PBA for the work "Hiring of Services of Land and Property Valuator/ Valuator Firm for CDA".
- The E-Bidding documents containing detailed terms & conditions, specifications and requirement etc. shall be available for the registered bidders on E-PADS at www.eprocure.gov.pk with effect from 11.09.2025.

The prospective bidders are required to submit their Bids online through E-PADS at http://eprocure.gov.pk and as per instructions contained in ITB of Bidding Documents on or before due date and time. In case the bids are not uploaded on E-PADS on or before due date and time, the manual bids shall not be accepted as per e-Pak regulations 2023. The Pre-bid meeting will be held on 17th September, 2025 at 11.00 AM in office of Deputy Financial Advisor-II, Executive block, Chairman, office, G-7/4, Islamabad.

The bidding shall be conducted in line with the Rule 36 (b) Single Stage Two Envelope procedure prescribed under Public Procurement Rules 2004, under Regulation 3(C): Least Cost Selection Method of the Procurement of Consultancy Services Regulations, 2010 and e-Pak Procurement Regulations, 2023 and is open to all prospective bidders registered in the "e-Pak Acquisition & Disposal System (E-PADS)".
