HIRING OF CONSULTANT FOR JCIA ACCREDITATION, HOSPITAL COMMISSIONING & INSTITUTIONAL READINESS

The Jinnah Medical Complex & Research Center Company (JMC&RC) Ministry of Health invites proposals both from National and International Consultants on Single Stage Two Envelope bidding procedure of Public Procurement Regulatory Authority Rule 36(b), for the hiring of Consultancy Services for JCIA Accreditation, Hospital Commissioning, and Institutional Readiness for its flagship 1200 bed tertiary care hospital. Evaluation will be carried out on **Quality and Cost Based Selection** method under PPRA Regulations 2010 for the Selection of the Consultants with 80% technical and 20% financial weightage.

Bid Submission Deadline:

All bids must be submitted electronically through the e-PADS portal (www.eprocure.gov.pk) no later than **11:00 AM** on **28th November, 2025**.

Bid Opening:

The bids will be opened electronically on the same day at **11:30 AM** in the presence of bidders or their authorized representatives who choose to attend.

Bidding Documents:

Interested and eligible bidders may download the detailed bidding documents, including terms and conditions, specifications, and requirements, from the e-PADS portal (www.eprocure.gov.pk).

Bid Security:

A Bid Security of **PKR Two Million (Rs.2,000,000)** must be accompanied with the Technical Proposal in shape of a Pay Order or a Bid Bond in favor of Chief Finance Officer, JMC&RC issued by any scheduled bank recognized by the State Bank of Pakistan (SBP). If the Bid Security is issued by any foreign bank, it should be countersigned by any scheduled bank duly recognized by the State Bank of Pakistan. A copy of the Bid Security shall be uploaded on EPADS in PDF format. The original Bid Security shall be submitted to the office of the undersigned on or before the closing date and time.
