Bids without such certificate shall not be considered.
- The prospective bidders are required to submit their Bids online through **E-PADS** at <http://eprocure.gov.pk> and as per instructions contained in Bidding Documents on or before **December 12, 2025, at 1130 hrs. Manual Bids will not be entertained.**
