The Directorate of Municipal Administration, MCI intends to license out the collection & disposal of poultry waste generated at seven (07) Weekly Bazaars (Itwar Bazaars G-6, H-9 & G-10, Mangal Bazaar H-9 & I-9, Budh Bazaar G-6 and Jumma Bazaar H-9, G-6 & Bara Kahu) through open auction for a period of one year (extendable subject to satisfactory performance with 10 % increase of bid value) on the following scheduled dates & time: -

#### Terms & Conditions:

1. The open auction will be held in the office of Director Municipal Administration, MCI Fire Headquarter Building G/7-1, Islamabad on scheduled Date & Time as mentioned above
2. All the interested participants of auction can apply up to one day before the auction date with the cash payment of Rs. 1000/- (Non-refundable) along with Rs. 100,000/- (Rupees One hundred thousand only) in the shape of call deposit in favour of DDO, DMA, MCI which will be adjustable in the amount of successful bidder.
3. Call deposit amount will be refunded to unsuccessful bidder next day, however, the call deposit of 2nd and 3rd highest bidder will be released after the issuance of license to successful bidder.
4. The successful bidder will have to deposit total bid amount in lump sum and 5% of total bid amount as security in the shape of pay order in favour of DDO, DMA, MCI within 03 days after issuance of bid acceptance letter. In case of default/ failure to deposit the bid offer by the highest bidder, the security shall be forfeited and the offer will be issued to next highest bidder.
5. Cash payments / cheques will not be accepted.
6. All the taxes will be deposited by the successful bidder.
7. The interested party must have the NTN.
8. The open auction will be held in the office of Director Municipal Administration, MCI Fire Headquarter Building G/7-1, Islamabad on schedule Date & Time as mentioned above
9. The bidders can visit these bazaars on any bazaar functional day to estimate the bid.
10. In case of non-occurrence of auction proceedings due to any reason including non-acceptance of bid, the auction process will be rescheduled on alternative date as mentioned above.
