5. Bid will be opened publicly on the **10-02-2026 at 11:00 A.M** in presence of procurement committee & bidders authorized representatives who choose to attend the opening session to be held at the office of Director Works, CDA located at Room No.21 old naval head quarter G-6, Markaz, Islamabad.
6. The firm providing unsubstantiated and/or incorrect information are liable to legal action and disqualification from the bidding.
7. The firm providing undertaking and original affidavit on judicial stamp paper for worth of Rs.500/-for non-blacklisting for any Government department and other Semi department our firm, Original stamp paper receiving before the date of opening technical bids.
8. The firm providing undertaking and original affidavit on judicial stamp paper for worth of Rs.500/-for non-relationship in CDA Official & Officer, Original stamp paper receiving before the date of opening technical bids.

In case if total bid amount is less than 10% below the N.I.T amount the bidder shall submit additional call deposit as performance security equal to the difference between N.I.T amount and total quoted amount less 10% of N.I.T amount the additional performance guarantee shall be submitted along with the bid. Bids having rates below 10% of NIT without additional call deposit will be rejected.
