- The prospective bidders shall upload scanned copy of Certificate is required on Original Judicial Stam Paper for each tender worth of Rs. 500/- their firm are not involved any litigations.
- The prospective bidders shall upload scanned copy of Certificate is required on Original Judicial Stam Paper for each tender worth of Rs. 500/- for non-relation ship in CDA.
- The prospective bidders are also required to submit their Bids online through E-PADS at <http://eprocure.gov.pk> before opening date. Original bids in accordance with the provisions of Rule 36(a) of Public Procurement Rules 2004 and terms & condition defined in the bidding documents.
- The prospective bidders are required to submit Work Order of RCC Box Culvert for Sr. No. 01 along with their Completion Certificate of Same/Similar Nature of Work for last year i-e 06.2024 to 06.2025 with CDA is mandatory. Without Work Order and Completion Certificate the Bid will be considered as disqualified.
- In case the total bid amount is less than 10% below the NIT amount, the bidder shall submit call deposit as performance security equal to the difference between NIT amount and total quoted amount less 10% of NIT amount. This call deposit shall be in addition to the earnest money for the work and shall be deposited at the time of submission of bids. Bids not carrying the performance security shall be rejected. The performance security of the successful bidder shall be released after completion of the project.
