The prospective bidders are required to submit Bid Security/Earnest Money (CDR) amounting to as above mentioned works in favour of Deputy Director Market & Roads Maintenance North, CDA issued from any schedule bank against firm's account. Name of Firm should be clearly mentioned on instrument (Call Deposit/CDR). The prospective bidders shall upload scanned copy of Bid Security on E-PADS and original will be submitted Seven (07) Days before opening of Bids & Pay Order is not acceptable.
- 4. The prospective bidders shall upload scanned copy of Certificate is required on Original Judicial Stam Paper for each tender worth of Rs. 500/- their firm are not involved any litigations.
- The prospective bidders shall upload scanned copy of Certificate is required on Original Judicial Stam Paper for each tender worth of Rs. 500/- for non-relationship in CDA.
- The prospective bidders are also required to submit their Bids online through E-PADS at http;//eprocure.gov.pk before opening date. Original bids in accordance with the provisions of Rule 36(b) of Public Procurement Rules 2004 and terms & conditions defined in the bidding documents.
- 7. The mode of procurement will be single stage two envelop. Interested bidders are required to submit both Technical and Financial Proposal. The technical proposal will be opened first. Financial bid shall only be opened of the technically qualified bidder.
- The prospective bidders are required to submit Work Order of Same/Similar Nature of Work along with their Completion Certificate of Same/Similar Nature of Work for last Six (06) Months with CDA is mandatory. Without Work Order and Completion Certificate the Bid will be considered as disqualified.
- The prospective bidders are required to submit Reliable Certification from UKICB Certifying Board of ISO 9001:2015 Quality
 Management System is mandatory. Without Reliable Certification from UKICB Certifying Board the Bid will be considered as
 disqualified.
- 10. In case the total bid amount is less than 10% below the NIT amount, the bidder shall submit call deposit as performance security equal to the difference between NIT amount and total quoted amount less 10% of NIT amount. This call deposit shall be in addition to the earnest money for the work and shall be deposited at the time of submission of bids. Bids not carrying the performance security shall be rejected. The performance security of the successful bidder shall be released after completion of the project.
- 11. Participants/firms must submit attested copies of relevant documents with original bid security/CDR's.
- 12. Work-related information may be sought from the office of Deputy Director Market & Roads Maintenance North, CDA.
- 13. In case of any gazette/occasional holidays the tenders will be opened on the next working day.
- 14. The bid security of all bidders will be deposited in CDA bank account and same will be returned after the acceptance of the contract with the successful bidder.
