Cash / Cheque or open CDR without indicating name of firm and applications without Bid Security / Earnest Money will not be accepted for issuance of tender / bidding document. The prospective bidders will also upload scanned copy of Bid Security / CDR on E-PADS.
- Tender / bids will be opened in the office of Director / Dy. Director (Civil) A/Sadr, CDA located at Room No.32, Ground Floor, A/Sadr Building, Islamabad on schedule date and time mentioned above.
- 4. The prospective bidders are also required to submit their Bids online through E-PADS at http://eprocure.gov.pk on or before tender opening date & time. Original bids in accordance with the provisions of PPRA Rule 36(a) and other terms & Conditions as defined in the bidding documents.
- 5. The eligibility criteria of firms having relevant experience and at least 03 No. of relevant work orders in last two financial years will be observed before issuance of tender documents.
