- Interested Firms/Contractors can download the bidding document from PPRA website and E-PADs portal only no hard copy will be issued, after filling up the bidding document and upload the copy of the same bidding document on E-PADs portal and also submit the application along with attested photocopy of same bidding document during any working hours in the office of Director (Enforcement), CDA Chairman Secretariat, Sector G-7/4, Islamabad before the closing date and time of tender i.e 11.00 a.m on 22.12.2025,
- Only firms / contractors registered with PPRA and E-PADs portal as vendors are eligible to enter the bidding documents.
- 3. Tender should be accompanied with Bid Security/Earnest Money (refundable) amounting to Rs. 150,538/- in from of Pay Order/CDRs in favor of DDO (Enforcement), CDA from any scheduled bank of Pakistan with the application. The prospective bidders shall upload scanned copy of Bid Security on E-PADs and submit original Pay Order/CDR in the office of DDO (Enforcement), CDA Secretariat Sector G-7/4, Islamabad before the closing time of tender i.e 11.00 a.m. on 22.12.2025 failing which the bid will not be accepted.
- The prospective bidders should submit their Bids online through E-PADs at (http://eprocure.gov.pk) of Public Procurement Rule-2004.
- The Bids will be opened publically on 22.12.2025 at 11:30 AM in the office of the Director (Enforcement), CDA Chairman Secretariat, Sector G-7/4, Islamabad by the committee members and in the presence of the representative of Firms/bidders/contractors.

- 7. Applications will be received alongwith the bidding document on printed pad name/address, signature of contractors with the following attested documents i.e valid CNIC copy, NTN number, the power of attorney, partnership deed, proprietorship deed, valid professional Tax Certificate, attested copy of NTN certificate, Non Relationship certificate, Non-Blacklisting certificate on judicial stamp paper worth of Rs. 100/- or above and registered proof with PPRA and E-PADs portal.
- 8. The Firms providing unsubstantiated and/or incorrect information are liable to legal action and disqualification from bidding.
- 9. Tender rates on percentage basis shall be written in figure, without any cutting/ overwriting and same shall also be in shown in words without cutting/over writing.
- 10. The Authority may reject all the bids at any time prior to the acceptance as per PPRA rules. However, the authority shall upon request communicate to any contractor who submitted a bid, on the ground of its rejection of all bids, but not bound to justify those grounds.
