The prospective bidders are required to provide the Bid Security/Earnest Money in the shape of **Deposit at Call (CDR)** generated from firm's account clearly indicating the Name of Firm issued by local scheduled bank in favor of Deputy Director, Mechanical Division-I, CDA in his office located at Room No.47, Ground Floor, Old Naval Head Quarter G-6, Islamabad before closing hours on 10-12-2025. (Bids of firms who have not provided bid security in original will be marked as non-responsive).2. Detailed bidding document containing bidding data, special terms & conditions, BOQ and technical evaluation criteria are available on EPADS at http://eprocure.gov.pk.3.The prospective bidders are required to submit their bids electronically through **E-PADS** at **http://eprocure.gov.pk** by uploading readable PDF files- before closing date & time in accordance with the provisions of **Rule 36(b)** (single stage two envelope bidding procedure) of Public Procurement Rules 2004.4. The prospective bidders are also required to submit uploaded copy of **Technical Bid** of each work clearly indicating name of work on the face of envelope along with an undertaking on Stamp Paper duly attested by notary public worth not less than Rs.50/, in which firm/contractor undertakes that all the requisite documents / information provided in the technical bids are genuine & correct and if any information or document is found incorrect or fictitious the firm/contractor is liable for disqualification and legal action under the law. Further it is also undertaken that firm has neither involved in any litigation nor black listed by any government, semi government or autonomous body in Pakistan. (Firms who have not provided the undertaking along with technical bids will be marked as **non-responsive). 5.** Firms must be submitted an attested hard copy of Technical Bid before closing hour, who support the eligibility of firm and technical criteria. 6. Financial Bid of only technical qualified firms/ Bidders will be opened after evaluation; date and time of financial bid opening will be informed later. 7. Tenders will be opened on EPAD system in the office of Director E&M (Development) located at Room No.49, Ground Floor, Old Naval Head Quarter G-6, Islamabad on schedule date and time in the presence of prospective bidders or their representatives who may choose to be present as PPRA Rules.8. In case the total bid amount is less than 10% below the NIT amount, the Bidder shall enclosed call deposit (CDR) in original with financial Bid as performance security equal to the different between NIT amount less 10% of NIT amount .That is, required performance security = Nit amount (-) total bid amount (-) 10% of NIT amount .This call deposit shall be in addition to the bid security / earnest money for the work. Bid having rates below the 10% of NIT cost not carrying the call deposit (CDR) shall be rejected and performance security of the successful bidder shall be released after completion of the project. 9.CDA may reject all bids or proposals at any time prior to the acceptance of a bid or proposal and conditional bids will also be rejected on the spot as per PPRA Rules. 10. The Bid Security / Earnest money of unsuccessful bidders will be retained / deposited in CDA bank account and released in the favor of firm's account only after acceptance of bid. 11.
