The last date for submitting complete bidding documents, accompanied by refundable Earnest Money/Bid Security of Rs. 5 million (Rupees five million only) in the form of bank draft or pay order in favour of DDO (Secretariat), CDA, is 26-08-2025, during office hours. Upon submission of complete documents along with the bid security/earnest money, a token will be issued for participation in the open auction.
- Only those applicants / bidders will be allowed to participate in the Open Auction who fulfil the requisite eligibility criteria substantiated with documentary evidence, and who have submitted Earnest Money/Bid Security, and are issued a Token Number.
