The prospective bidders shall upload scanned copy of Bid Security on E-PADS and original will be submitted in the office of Director (S,C&T), CDA Conference Room Old Navel Headquarters G-6, Islamabad along with the Bids.

The bids, prepared in accordance with the instruction in the bidding documents, prospective bidders are required to submit their Bids online through E-PADS at http://www.eprocure.gov.pk before the opening date. Original Bids must be submitted in the office of Director (S,C&T), CDA Conference Room, Old Navel Headquarters G-6, Islamabad on or before 05-11-2025 at 11.30 AM on 05-11-2025 The bids

will be opened at 12:00 PM on same date in the presence of bidder's authorized representatives who choose to attend.

5. Notification of the GRC constructed in terms of Rules-48 of public procurement rules-2004 is provided on www.cda.gov.pk, on EPADS at

http://eprocure.gov.pk and www.ppragov.pk.

The prospective is also required to submit an undertaking on stamp paper duly attested by notary public worth not less than rupees 500/- (five hundred) that the firm/Contractor are neither involve in any litigations nor black listed by any government, semi-government or autonomous body in Pakistan and also undertakes that if any information or documents provided by firm for issuance of tender documents is found incorrect or fictitious the firm is liable for disqualification and legal action under the law. Without the undertaking tender will not be issued to firm.

 In case of total bid amount is less than 10% below the NIT amount, the bidder shall enclosed additional call deposit (CDR) in original with bids as performance security equal to the difference between NIT amount and total quoted amount less 10% of NIT amount. That is NIT

amount (-) total bid amount (+) 10% of NIT amount.

8. If any contractor wants to participate in tender opening process through their representative, they should issue authority letter on letter head pad of the firm depicting complete valid address & contact numbers along with attested copy of CNIC.

9. Authority may reject all bids or proposals at any time prior to acceptance of bid or proposal. The CDA shall upon request communicate, to any supplier or contractor who submitted a bid or proposal, but is not required to justify those grounds.
