Secretary, M. Naem Ullah, hereinafter called the "Transferor":-

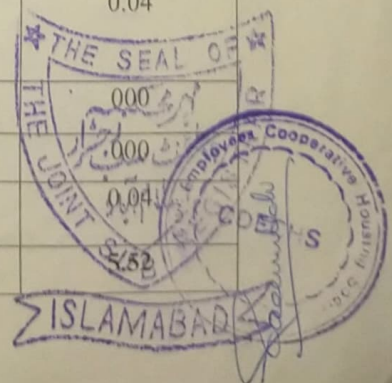
IN FAVOUR OF
