- 2. Vide this office letters dated 25-11-2016, 9-12-2016 and 27-2-2017, Management of CECHS was asked to refrain from sale/purchase and booking of plots in violation of approved Layout plan of the scheme, stop the unauthorized and illegal development within and outside the approved layout plan area, remove / dismantle illegal access from Islamabad express way, restore the actual land uses of approved layout plan and deposit the fee/penalty imposed on them failing which legal action would be taken by the Authority. The reply submitted by management of CECHS, is un convincing and against the facts.
- 3. Above in view, the NOC of Soan Garden Housing scheme sponsored by the M/s Civilian Employees Cooperative Housing Society approved by CDA on 9-8-2004, is hereby withdrawn/cancelled with immediate effect, under the provisions of Clause 5(ii), Chapter-IV of ICT (Zoning) Regulation, 1992.
