- Bids must be accompanied by a Bid Security should be in the form of Pay Order / CDR in favor of DDO (Maint) MPO. The prospective bidders shall upload scanned copy of Bid Security on E-Pads in PDF and original will be provided one day before submission of bids in the office of Dy:Director (Maint:), MPO, CDA.
- In case of total bid amount is less than 10% below the NIT amount, the bidder shall submit additional call deposit as performance security equal to the difference between NIT amount and total quoted amount less 10% of NIT amount the additional performance guarantee shall be submitted alongwith the bid. Bids having rates below 10% of NIT without additional call deposit will be rejected. The performance security of the successful bidder shall be released after completion of project.
