TERMS AND CONDITIONS FOR BIDDERS:-

- The Capital Development Authority invites bids, from firms, registered with Pakistan Engineering Council having valid Registration Certificate in respective project code valid for the year 2024-25 who can prove their eligibility and qualification as mentioned in Bidding Documents for the above mentioned work.
- The bidding shall be conducted in line with the Rule 36(a) Single Stage Single Envelop procedure prescribed under Public Procurement Rules 2004, E-PAD Procurement Regulations 2003 and is open to all potential bidders registered in the E-Pak Acquisition & Disposal System (**E-PADS**).
- Bids must be accompanied by a Bid Security duly generated from firm's own account should be in the form of Pay Order/CDR's in favor of **D.D.O (East), Environment Wing, CDA**. The prospective bidders shall upload scanned copy of Bid Security on E-PADS and original Bid Security /CDR's before 12:00 (Noon) dated **31-07-2025**. Along with application and documents mentioned at Serial Number 8, will be submitted to the office of Director Environment (East), CDA at 9th Avenue, Environment Directorate (East), CDA office F-9 Park, Islamabad.
- The bidder must appear in person while submitting the application. In case of absence of the bidder, an authority letter must be provided along with application on letter head of the firm depicting complete valid address & contact number along with attested copy of CNIC.
- The electronic Bids must be submitted by using **E-PADS** on **01st August 2025** till **11:30 PM**, manual bids shall not be accepted. Electronic Bids will be opened on the same day at **01st August 2025** at **12:30 PM**, on (www.eprocure.gov.pk) in the presence of the representative of the bidders. Late bids shall not be entertained. The Bids will be opened publicly in the office of Director Environment (Park Division), CDA at 9th Avenue, Environment Directorate (East), CDA office F-9 Park, Islamabad.
- The eligibility criteria of the firms with the relevant experience and Similar Nature of work executed / performed i.e. at least three numbers of works done in last two financial years may be observed / full filled.
- Application for issuing of tender documents submitted on printed pad bearing name / address / signature of contractor along-with power of attorney, partnership deed, and proprietorship deed, valid professional Tax Certificate, renewal PEC license, attested copy of NTN certificate, attested copy of CNIC and Registered proof with PPRA on E-PADS.
