The Capital Development Authority (CDA), Islamabad, through its Building & Housing Control Wing (B&HC), invites Expressions of Interest (EOIs) from reputable, internationally renowned hotel operators / hospitality brands for the operation, branding, and management of a premium hotel project located at two premium plots, located in Sector F-5, directly behind Marriott Hotel Islamabad's most prestigious hospitality district.

Plot No. 6 – 4.51 Acres (21,970.6 sq. yds) Plot No. 8 – 3.73 Acres (18,162.8 sq. yds)

These plots are earmarked for international-standard hotels, serviced apartments, and allied hospitality uses to meet Islamabad's growing tourism, business, and diplomatic accommodation needs. The objective of this EOI is to prequalify reputable international hotel operators possessing demonstrated global experience, operational capability, and strong brand standing to partner with CDA in the development and operation of a world-class hospitality facility in the Federal Capital.

Scope of Engagement

The selected hotel operator / brand shall be expected to:

- .Provide international hotel branding and positioning
- Operate and manage the hotel in accordance with global hospitality standards
- Ensure service quality, operational efficiency, and guest experience excellence
- Deploy international best practices in hotel management, marketing, and sustainability
- Train and develop local human resources as per international benchmarks

Eligibility Criteria

Interested hotel operators / brands must meet the following minimum requirements:sortium/JV profile;

- Must be an internationally recognized hotel brand/operator with an established global presence
- Minimum 10 years of international hotel management experience
- Operation and/or management of at least five (5) international hotels in major cities worldwide
- Demonstrated experience in managing 4-star/5-star/luxury hotels or resorts
- Strong financial standing and proven operational track record
- Compliance with international hospitality, safety, and sustainability standards

Contents of Expression of Interest (EOI)

- 2. Global Portfolio & International Experience, detailing operated hotel brands, locations, categories, and geographic presence
- Experience in Similar Hotel Projects, with relevant project details and references 3.
- Proposed Brand(s) for the Islamabad project, including a brief positioning concept and brand value proposition 4.
- 5. Preferred Operating Model, whether management, franchise with technical services, or a hybrid structure. (Note: No financial proposal is required at this stage)
- Project References, for at least two (2) hotel projects of 200+ rooms each, where the operator was engaged prior 6. to commencement of construction
- Organizational Structure & Key Management Personnel, including pre-opening and technical teams 7.
- 8. Proposed Operational Philosophy, service standards, and operational approach
- 9. Relevant Certifications, Awards, and Recognitions, if any
- Key Contact Person / Project Lead, including name, designation, email address, and contact number 10.
- 11. Any Additional Information supporting the firm's technical, operational, and brand suitability for the project
