All the Sponsors, are again requested through this Public Notice, to provide the requisite Data/Info, as aforementioned, in Hard & Soft Formats, in 7 days of the issuance of this Notice, without Excuse. In case of failure, necessary action shall be initiated, including but not limited to Surprise Visits of the said Joint Committee, in the Offices of respective Sponsors of the Private Schemes/Projects, for Collection of Data on Spot.
