- The prospective bidders are required to submit an undertaking on Stamp Paper dully attested by notary public worth not less than Rs. 100/- that the firm / contractor are neither involved in any litigation nor block listed by any government, semi government or autonomous body in Pakistan and also undertakes that if any information or document provide by firm for issuance of tender document is found incorrect or fictitious the firm is liable for disqualification and legal action under the law. **Bids of firms who have not provided the undertaking along with bid security in original will be treated as non-responsive.**
- The prospective bidders are required to submit their bids electronically through **E-PADS** at <http://eprocure.gov.pk> by uploading readable PDF file before closing date & time in accordance with the provisions of Rule 36(b) of Public Procurement Rule 2004. **No hard / manual bids are acceptable.**

- Tenders will be opened on EPADS system in the office of **Dy. - CDA can reject all bids or proposals at any time prior to the acceptance of a bid or proposal and conditional bids will be rejected at the spot as per PPRA Rules.
- The Bid Security / Earnest money of unsuccessful bidders will be retained with CDA and will be released in favor of firm's account only after acceptance of bid.
