**Subject:- DISPLAY OF APPROVED LAYOUT PLANS OF PRIVATE HOUSING
SCHEMES/PROJECTS IN ICT, ISLAMABAD**

Ref:- Please refer to Regional Bureau National Accountability Bureau (Islamabad / Rawalpindi), letter No. 28/04/A&P/NAB/RWP/26, dated 11-5-2026, regarding the subject matter.

It has been conveyed by NAB that, it has been observed that Sponsors and Developers in the Housing Sector are misrepresenting the Approval Status of housing schemes by **Not Displaying Approved Layout Plans** or by presenting **outdated or unapproved plans to the public**. This lack of transparency misleads prospective buyers and creates a false impression regarding the legal status of such schemes, ultimately resulting in loss and hardship to the general public. Therefore, in order to safeguard the interest of the general public from deception and fraud, it is essential to ensure transparency through the availability and display of verified and updated information regarding **approved layout plans** of housing schemes /projects under the jurisdiction of CDA.

2. In view of above, it is advised that necessary directions may be issued to the Planning and Enforcement Wing, to ensure that all housing societies/schemes must:

- a. Upload and regularly update the approved layout plans, on their respective official websites.
- b. Prominently display the approved layout plans and their current status at the reception areas of all sites and booking offices. The display must be at least **7x5 feet** (or sized appropriately for the available space) to ensure maximum visibility. Additionally, a QR code must also be included on the display, linked directly to the official website for access to detailed project updates.

3. This initiative will enhance transparency, protect public interest and help to prevent illegal or unauthorized housing practices. Therefore, it is advised that necessary directions may be issued for implementation of the above promptly, and compliance report be forwarded to this Bureau on priority, please.

4. Further, Clause-40(7 to 10 & 15) of the "Regulation for Planning and Development of Private Housing/Farm Housing, Apartments/ Commercial Schemes/ Projects in Zones-2, 4 & 5 of Islamabad Capital Territory, 2023",

7. All allotment letters, in case of Housing/Farm Housing Scheme, Commercial Scheme, Vertical Housing Project and Standalone Commercial Project, issued by Sponsors shall be shared with CDA through a Digital Platform i.e. Management Information System (MIS)/ERP at the cost of Sponsor, for regulating the Saleable Area within approved Layout Plans and Building Plans, respectively, of such Schemes/Projects.
8. No allotment letter, whether original, provisional or through transfer, in case of Housing/ Farm Housing Scheme, Commercial Scheme, Vertical Housing Project, Standalone

Commercial Project, should bear any credence unless vetted (with signed & stamped) by the concerned Director (Planning) or the Officer not below the rank of Director (Planning), specifically authorized by the Member (P&D), CDA, in this regard. This facility of Vetting will be provided to the Schemes/Projects, wherein the Sponsors have executed the Transferred & Mortgaged Deeds of Plots/Land, in favor of CDA, under the provisions of this Regulation, in the best interest of the public.

9. The concerned Directorate of Planning Wing, through the above MIS or ERP will ensure that only those Plots will be allowed to be allotted/transferred which are part of Approved Layout Plan of Housing/Farm Housing Scheme, Commercial Scheme. Similarly, only those units will be permitted to be allotted/transferred which are part of approved Building Plans of Vertical Housing Project, Standalone Commercial Project. In both the cases, the Plots/ Units/Land, Transferred to & Mortgaged with the Authority, under the provisions of this Regulation, shall not be allowed to be Allotted/Transferred, until redeemed by the Authority.
 10. CDA will charge, from the allottees/transferees, fee of Rs.100/- per Sq. yd. of the area of Residential Plot and Rs.1,000/- per Sq. yds. of Commercial Plots in Private Housing/Farm Housing/Affordable Housing Schemes. Similarly, Rs.50/- per Sq. Ft. of the Apartments and Rs.100/- per Sq. ft. of Commercial Units in Apartment/Commercial Projects, respectively, on account of Record Maintenance Fee.
 15. The Sponsors of Schemes/Projects shall have a Website as per approved format duly connected to CDA Website containing details of land ownership, its location, approved Layout Plan of Scheme Project, NOC, Details of Public Amenities, Plots Mortgaged with CDA and total residential, commercial and amenity plots. The Sponsors shall update the Website, regularly.
5. In the light of position detailed above, All the Sponsors of Private Housing Schemes/Projects are directed to strictly comply with **the Instructions of NAB and Mandatory Regulatory Provisions, as aforementioned**. A Compliance Report along with evidence like photographs must be submitted to this office within **10 Days** of the issuance of this letter for onward submission to NAB (Islamabad/Rawalpindi). Non-compliance of the said instructions will be intimated to NAB, which may initiate necessary legal actions, in this regard.
