Prospective bidders shall upload a scanned copy of Bid Security in PDF form on E-PADS along with the bid and the original will be provided 2 days before submission of bid in the office of Deputy Director (Sector Development Division-II), CDA.
3. Prospective bidders are required to submit their bids online through E-PADS at <http://eprocure.gov.pk> as per instructions contained in the bidding documents on the date and time mentioned above. Manual bids will not be entertained.

Electronic bids will be opened using E-PADS publicly on the date and time mentioned above in the presence of the Procurement Committee and bidders or authorized representatives who choose to attend the opening session to be held in the office of Director Sector Development, CDA Room No. 55 & 65, Ground Floor, Old Naval HQ, G-6 Markaz, Islamabad.
