1. Purpose & Procurement Procedure:

The CDA intends to lease, on a rental / revenue-sharing basis, a purpose-built

space at Gardenia Hub & Research Centre, Park Road, Islamabad, for operation

of a branded coffee shop with an ancillary book-corner (the "Project").

Procurement shall strictly follow the Single-Stage - Two-Envelope method

prescribed under Rule 36(b) of the Public Procurement Rules 2004 (PPRA

Rules):

Bidders shall submit one sealed package containing two separate envelopes:

Envelope-A – Technical Proposal

Envelope-B – Financial Proposal

Both envelopes will be received on the due date and only Envelope-A will be

opened in the first public session.

Financial envelopes of technically responsive bidders will be opened in a

second public session on a notified date.

The bidder with the highest combined score (technical 70 %, financial 30 %)

will be declared Best Evaluated Bidder (Rule 40).
