- The bidding shall be conducted in line with the Rule 36 (a) Single Stage Single Envelop procedure prescribed under Public Procurement Rules 2004 E-Pak Procurement Regulations 2023 and is open to all potential bidders registered in the e-Pak Acquisition & Disposal system (EPADS).
- The prospective bidders are required to submit their bids online through E-PADS at <http://eprocure.gov.pk> before the deadline on the specified date and time. Manual bids will not be entertained.
- The bids will be opened by using E-PAD on respective date and time in the presence of the Procurement Committee & bidders / authorized representatives in the office of Director Sewerage WWT, CDA, Room No. 140 1st Floor, Old Navel Headquarters, G-6, Islamabad.
- Firms must provide an undertaking on **stamp paper (original)** declaring that the firm/contractor is neither involved in any litigation nor blacklisted by any government, semi-government, or autonomous body in Pakistan. The undertaking must also state that if any information or document provided by the firm is found to be incorrect or fictitious, the firm shall be liable for legal action under the law.
- Work-related information may be sought from the office of Dy. Director City Sewerage Division, CDA.
- The following documents must be submitted in person to the office of **Deputy Director, City Sewerage Division, CDA, Room No. 147, 1st Floor, Old Navel Headquarters, G-6, Islamabad** :(Deadline: All documents along the original bid security, must be submitted on or before 24-06-2026. Failure to do so will result in automatic disqualification of your bid)
 - Attested Copy of the PEC Registration Certificate
 - Original Bid Security (The name of the company must be clearly written on the CDA/Pay Order)
 - Affidavit (As required in Sr. No. 4 of this tender Notice)
 - Active NTN and GST Certificates.
 - In case of an authorized representative, a copy of the CNIC along with the General/Special Power of Attorney attested through the respective Court. Firms must provide in undertaking declaring that the attorney holder should not be an employee of any Government/semi-government institutions.
 - Tender Form Requirement:**
 - Ensure that the rates and Pay Order/CDR number and firm name are correctly entered at the designated places, otherwise, the bid shall be considered invalid and will be rejected without any further notice
 - All sections must be completed.
 - Tender form must bear the contractor's signature and official stamp on all designated places.
- All participating contractors are required to upload the complete set of NIT documents. Incomplete submission including partial of selective pages of NIT, shall be considered invalid and will be rejected without any further notice.
- CDA may reject all bids or proposals at any time prior to the acceptance of a bid or proposal as per PPRA rule. In case of any gazette/occasional holidays, the tenders will be opened on the next working day. The tender notice can be viewed on both the CDA website (www.cda.gov.pk) and the PPRA Website (www.ppra.org.pk), as well as the E-PADS portal.
