

TENDER NOTICE

The Capital Development Authority invites electronic bids through PPRA e-Bidding System (**EPADS 2.0**) from well-reputed firms/contractors registered with the Pakistan Engineering Council (PEC), having a valid PEC registration in Category C-6 or above with specialization code **CE09(i)** – Sewerage Works, valid for the year 2026-27, and fulfilling the eligibility and qualification requirements as specified in the bidding documents, for the following work:

- Single Stage-One Envelope Procedure under Open Competitive Bidding shall be adopted using the **Least Cost Based Selection (LCBS)** technique in accordance with Public Procurement Rules, 2004 any Regulations, and Instructions issued by the Authority (from time to time).
- The Bid Security must be submitted in person to the office of Deputy Director, City Sewerage Division, CDA, Room No. 147, 1st Floor, Old Navel Headquarters, G-6, Islamabad :(Original bid security, must be submitted **on or before 29.09.2026**. Failure to do so will result in automatic disqualification of your bid).
 - Original Bid Security **in favor of DDO City Sewerage Division** (The name of the company must be clearly written on the CDA/Pay Order
 - In case of an authorized representative, a copy of the CNIC along with the General/Special Power of Attorney attested through the respective Court. Firms must provide in undertaking declaring that the attorney holder should not be an employee of any Government/semi-government institutions.

E-bids will be opened by using EPADS v2.0 on the same day at Thursday, October 1, 2026 12:00 PM. Manual submission of Bids shall not be entertained.
